## UPDATE: PROCESS FOR CHOOSING THE PAYMENT OPTION BY CREDITORS OF SENIOR UNSECURED NOTES

We hereby inform you that, for the benefit of creditors, the "Deadline for Choosing Payment Option" provided for in Section 4.4 of the Judicial Reorganization Plan of Cimento Tupi S.A. – Em Recuperação Judicial, approved on May  $3^{rd}$ , 2024, by terms of adhesion signed by creditors representing more than 50% (fifty percent) of the credits subject to the judicial reorganization (in value and headcount) ("<u>Plan</u>"), will be extended for another 10 (ten) days and will end on <u>August 12<sup>th</sup>, 2024</u>.

In this case, the Class III Unsecured Creditors, whether or not holders of Senior Unsecured Notes, with exception of the Strategic Supplier Creditors, will have until <u>August 12<sup>th</sup>, 2024</u>, to submit their respective choices of payment option among those provided for in the Plan.

The payment option will become effective as soon as the Class III Unsecured Creditors submit the PAYMENT OPTION NOTIFICATION, provided in Schedule 4.4 of the Plan, it being certain that the Class III Unsecured Creditors holders of Senior Unsecured Notes **<u>must send their payment option choices</u>** through the ATOP system (Automated Tender Offer Program) of the DTC (Depository Truste Company) and, together with such choice, send the payment information described in the notifications sent to the Class III Unsecured Creditors holders of Senior Unsecured Notes by Kroll Restructuring Administration (the agent contracted by Cimento Tupi), in accordance with the guidelines set forth in such notifications, as required by the foreign rules governing Senior Unsecured Notes.

## CREDITORS WHO DO NOT SEND THE PAYMENT OPTION NOTIFICATION WITHIN THE PERIOD INDICATED ABOVE SHALL BE PAID IN THE FORM OF SECTION 4.3.1.4 OF THE PLAN ("General Payment Method"), as expressly provided for in Section 4.4.4 of the Plan.
